Write a Will is as soon as you have something to leave to others. Whatever you

leave becomes someone's inheritance. In due season, family, friends, your church or charity could be blessed by the inheritance you have thoughtfully planned.



The Bible speaks plainly and often about inheritance. An inheritance is what we receive and also what we leave behind for others. What we leave for others should reflect our lifelong stewardship and generosity. One way to insure this commitment is through a Will and estate plan.

An inheritance can be a burden or a blessing. We must take into consideration the season of life we're in and the life states of those directly affected by our living and leaving.


A BRIEF GUIDE TO WILLS AND ESTATE PLANNING

... and a time for every matter under heaven. Ecclesiastes 3:1

Why have a Will?

Will gives instructions to your survivors on how to distribute your estate

after your death. Your estate is everything you own. Cars, house and other real property, cash stocks, golf clubs, computers, jewelry, and other personal property all constitute your estate. The total often is greater than we imagine, but a Will is necessary and impor-



tant regardless of the size of the estate. Without a Will, the distribution of your property will be dictated by the laws of your state.

Who should have a Will?

very person needs a Will regardless of her/his life season. A couple with young children can decide who will be their children's guardian. An older person may decide to leave an inheritance to grandchildren not yet born. A single person can avoid burdening parents with deciding how to distribute his or her assets, and a spouse can make tax-wise decisions to the benefit of the surviving partner. As life's circumstances change, your Will needs to be updated.

How do I write my Will?

our Will should be your final testimony of Christian commitment. Make a list of your dependents or people for whom you are responsible. Make a list of your property, stocks, cash, cars, life insurance, IRAs and any other assets and valuable possessions. Next, think of any person or charity you would like to remember. Doing your homework first will save you time and expense. Finally, take your lists to a legal advisor. Your Will is best written by a legal professional familiar with the laws of your state.



What can I accomplish with my Will?

- Name an executor
- Determine how your assets are distributed
- ◆ Choose your children's guardian
- ◆ Leave a gift to your church, Conference or UCC National Ministries
- Proper tax elections in the Will may result in the reduction of estate taxes

How can I include the church?

ou can make a gift several ways:

Specific amount: State a specific dollar amount (but make sure you review your Will regularly).

Gift by percentage: Give a percentage of a particular asset, or a percentage of your estate.

Residual bequest: Give the remainder of your estate after your survivors have received their inheritance.
