General Minister & President Report by Rev. Dr. John Dorhauer

John Dorhauer spoke on three matters before the Church:

Budget process and challenges, the pending move to AECOM, and state of the Church and the adaptations made during the pandemic.

John confirmed that he will not forward name to GS in 2023 for 3rd term as GMP.

Traci Blackmon provided an update on Pilgrim Press, Youth Ministries, Manual on Church, the launch of the new ministerial and congregational profiles system, Join the Movement, Frontline Faith, work of the Washington DC office, medical debt abolishment and the co-sponsored fellowship with CHHSM on reproductive justice.

Wider Church Ministries Associate General Minister Report by Karen Georgia Thompson

Karen Georgia Thompson provided an update on the finalization of the GS33 report. Planning for GS34 has begun.

Many of our partners continue to struggle with COVID. Some of our partners are struggling with access to vaccines. We continue to deploy mission personnel.

We are giving attention to Common Global Ministries Board appointments and in bringing the standing rules of that body into alignment with unified governance.

Disaster Ministries is very active. We have a new staff person for refugee resettlement issues and continue to engage in work related to the United Nations.

What is happening with the Amistad Chapel in context with the move?

Traci Blackmon responded: Amistad Chapel is not being dismantled and being reassembled in the new space. The new space cannot accommodate it. We will be using the wood in the new space. It will not look like the Amistad Chapel but the spirit will be with us.

We are pursuing conversations with covenanted partners on the story of Amistad and contacted Franklinton Center at Bricks and asked if they would be willing to receive the gift of the organ from the chapel.

How are we addressing the issue of the Shrinking Church?

Traci Blackmon responded: This issue has been before the Board for years. We need to create a group to hear from others who have gone before so we are not re-doing work that had been going on in the past. We are looking for new ways of being church that we are not currently exploring.
