## **COMMITTEE REPORTS**

## Marketing Committee Report By Kearstin Bailey

The Committee will meet once each quarter to discuss how to market the UCC and the way we show up as a denomination. We will also discuss how our digital communications work and audit the digital resources.

## Investment & Endowment Committee Report By Careina Williams

The approved draw is a 3.3% increase from 2022. From 2015-2022 we were drawing \$7.5-8 million and this year we are drawing \$11 million. We are also working on the governance and roles of the various parties and updating benchmarking. Portfolio allocation has been conservative. We are trying to re-examine the portfolio allocation to gain more returns. We are building DEI into the investment policy. Our goal is to have the policy done by the end of the year. We are going to have 4 meetings a year with a focus on performance. Right now, the endowment is at \$314.5 million, a 3% increase for the 2<sup>nd</sup> quarter and 6.3% increase since inception. We want to be sustainable into the future.

We are going to work with 3<sup>rd</sup> parties to be able to compare data with historical data. The draw amount from the committee is not in a percentage because it cannot be done accurately.

#### **Discussion:**

The amount of \$11,340,176 is a combination of the approved draw and admin fee. The amount had previously been in the form of a percentage.

In 2015 the draw dropped to 4.75% calculated on the unrestricted balance of the endowment, \$7.6 million to \$8 million. In 2023 we approved \$11 million, a 45% increase over the prior year. We cannot stay at this level. The endowment will be impacted.

The Board last year for the first time approved an administrative fee on the endowments. Rather than take the draw on the unrestricted funds, we would also take an admin fee across the funds to reduce the amount needed on the draw. The action was taken due to the added staff in the Philanthropy Team, the decrease in OCWM, and the increase in health and dental insurance. The staff were to be funded by the resources drawn on the administrative fee. The goals set for philanthropy are impacting the operational budget. The needs we have and the commitment to the Philanthropy Team take three years to show up. We will still need to determine if the Philanthropy Team is earning a return on investment.

OCWM has consistently dropped. The request last year was to cover some of the drop. There was also a 10% increase in health insurance and 8% in dental.

## Finance & Budget Committee Report By Mark Dutell

The Committee met on October 3 and a balanced \$22 million budget was submitted for review. Karen Georgia gave an overview to the committee. The budget represented a change of \$643,000; 1% cost of living adjustment; staff travel requests at the 2022 level. There is an increase in health insurance and an increase in dental insurance.

The Committee reviewed the National Basic Support Allocation. The moneys are allocated to OGMP, JWM, LCM, WCM, PB and GS infrastructure. The allocations basically are the same as last year. The money is already budgeted – this is the allocation of the central costs.

To approve the National Basic Support allocation base of \$3,800,000 for 2024 and the funding to the Office of the General Minister & President, the Covenanted Ministries and the Pension Boards allocation as follows: Office of the General Minister and President (OGMP) \$633,454 or 16.7%, Justice and Witness Ministries (JWM) \$826,310 or 21.7%, Local Church Ministries (LCM) \$950,000 or 25.0%, Wider Church Ministries (WCM) \$950,000 or 25.0%, The Pension Board \$216,546 or 5.7% and historical grants and General Synod infrastructure \$223,690 or 5.9%.

The Committee has fifteen members: 8 are on the UCCB and 7 members are UCC At Large. The chair of the CGM Committee is co-chair of Common Global Ministries Board.

On October 2<sup>nd</sup> we had a brief orientation as a new committee, an update on the transition process, and an overview of the budget. We will meet on November 10<sup>th</sup> in Indianapolis and on November 11<sup>th</sup> and 12<sup>th</sup> the Common Global Ministries Board will have its Board meeting.

## **United Church Funds by Charles Buck**

The primary mission of United Church Funds is to support the mission of UCC. It is our goal to do responsible investing. We are leveraging assets with engagement with the funds. There is a divestment from fossil fuels fund. Managers are becoming more diversified. Currently over 60% of managers are diverse.

## Pension Boards - UCC Inc. by Brian Bodager

Brian Bodager spoke to the board of Pension Boards. There are twenty individuals on the Board, half are clergy and half have finance, insurance, and investing expertise. The Governance Committee for Board accepts applications and vets them and send them to the UCCB Governance Committee for addition to the pool. The Board has term limits. Three members will be coming off the Board and they are currently looking for folks to sit on the Board.

Generations United Credit Union has plans to open in January. Pension Boards provides supplementation for small annuities. In 2024 it will supplement each clergy annuitant to receive \$43,000 per year. Funding for this program comes from OCWM monies and special mission offerings (Christmas Fund, Special Mission appeal; Christmas in July).

Ministers Vitality Initiative was created for purposes of paying off student loan debt. Generations Resources specializes in lending for clergy.

We have been speaking with our Puerto Rican partners. There is a \$3 million + shortfall in their program. We are working with them to close the gap.

The healthcare program is generally impacted by the market. It is self-insured. Every year since 2015 the program has been supplemented with millions of dollars from our reserves. The retiree program was handed over to a fully insured provider.

# **Development Committee Report By Lawrence Richardson**

The Development Committee is pleased to work alongside the Philanthropy Team of the church. The Philanthropy Team has added five members to their team. Planned giving will be a focus in 2024. There is a collaboration of efforts between Center for Faith and Giving (Disciples) and PB planned giving efforts.

The Audit Committee members were introduced. The Committee met on September 29<sup>th</sup> with the Auditors. The Committee reviewed the audit and report that it is a clean audit. The financial management is well served by the team that we have. Our endowments went down by 50M dollars.

## General Synod Program and Planning Committee: GS de-brief By Karen Georgia Thompson

Karen Georgia acknowledged the GSP&P Committee. The Board members commented on what worked at General Synod and what we can do better.

<u>Highlights of what worked include</u>: Committee work on the resolutions; use of technology – being able to vote from outside of the hall; work in worship – building the church in an affirming way and celebrating diversity; theological reflections; Speak Out!; speakers.

<u>Highlights of what can be done better</u>: space needed does not need to be a convention hall; space should not be shared space; downtown spaces are expensive; tight scheduling which forced making choices; lack of non-English worship; few youth activities.

Two thousand General Synod surveys were sent out. Only 600 replies were received.

## Update from CCM By Kim Wood

The Council of Conference Ministers represents six different regions. Each region selects a Conference Minister to come to the UCCB. The Council meets quarterly. There will be a relationship building retreat in Tucson in January. There are several transitions taking place: Lee Albertson completed his role at the end of September and Diane Weible will work as the interim. The Council is working with the Philanthropy Team through General Synod to build strong partnerships.

# Vice-Chair Remarks By Jasmine Coleman Quinerly

The installation of Karen Georgia represents change. Be intentional when you return to your home – share with your congregations, community, Conference, and associations. Find three congregations you have not been to and share what you have learned. You will change their story – they will have the experience of the UCCB and the new GMP and a way to understand the vision of the future.
