# Sign on Letters for Transgender Rights

#### **Public Student Loan Forgiveness letter:**

"ED would be authorized to deem ineligible countless employers, including state and local governments and non-profit organizations that engage in work that the Administration disagrees with, such as helping immigrants, providing healthcare to transgender youth and adults, advancing equity in schools and workplaces..."

#### National Women's Law Center letter:

"Furthermore, Congress must work to complete the appropriations process free of harmful riders targeting LGBTQI+ people, racial equity, immigrants, and access to reproductive health care....attempts to further restrict abortion access for military service members and veterans, bans on genderaffirming care, attempts to prohibit transgender and intersex women and girls to play school sports with their peers, attempts to prohibit implementation of regulatory protections for students who are survivors, LGBTQI+, and pregnant and parenting, and efforts to undermine the U.S. asylum system that harms immigrant survivors of gender based violence."
